**Impact of the PPG**

Through rigorous teacher assessment which was moderated externally by County, every child in receipt of the Pupil Premium Grant achieved national expectations.

One year 6 child, in receipt of PPG demonstrated national expected standard during the SAT for Reading and the TA for writing. The pupil missed the SAT for mathematics by 2 marks, therefore

### **Impact**

The impact of the PPG is positive by evidence. Both children in receipt of the PPG met age related expectations and achieved the expected standard for their national assessments. This is a direct result of their emotional stability offered on a 1:1 basis by a specialist and as a result of the training given to our support staff.
